Conditions for submitting a Tender

You are advised to ensure you are fully familiar with the nature and extent of the contract. Please note that the contract cannot be for more than the value of £56,988.16 including VAT. In addition to providing a Tender, firms are invited to include a detailed pricing submission of the Tender for consideration if they consider it appropriate to do so or where NCAT has requested this as part of the Specification.

You are invited to submit your proposals electronically, via Glenn Pendleton's email. NCAT will evaluate your Tender on the grounds of your proposals and price in accordance with the evaluation criteria listed below.

It is your responsibility as a firm submitting a Tender to obtain for yourself and, at your own expense, all information necessary for the preparation of their Tender. NCAT will not pay any fees or expenses whatsoever for submitting a Tender.

In the event that you are successful in your Tender submission, we will contract with you in accordance with our terms and conditions as attached. Please note that NCAT will contract only on its own terms and conditions. NCAT may at its absolute discretion extend the closing date and time specified for receipt of Tenders or invite variations to the Specification but will do so in writing to all firms.

NCAT reserves the right to reject any unrealistically low or high Tenders that it receives.

By submitting this Tender, you agree to keep your price at the amount stated below for at least ninety (90) days.

Evaluation

NCAT will evaluate the Tenders to decide the Most Economically Advantageous Tender taking into consideration the following criteria.

1 Strength of proposals to comply with our Specification - Evaluation made on methodology submitted in response to the Invitation to Tender – 80% weighting

This evaluation is made up with the following sub-weightings:

- Staffing and Management Structures 45% weighting
- Timescales for Starting and Completion 55% weighting

The scoring rationale behind the evaluation criteria is in accordance with the graduated approach set out in the following table:

100	Exceptional response in all areas
90	Exceptional response with some minor shortcomings, or very good
	response with some exceptional elements
80	Very good response in all areas
70	Very good response with some minor shortcomings, or good response
	with very good elements
60	Good response in all areas
50	Good response with some minor shortcomings, or acceptable
	response with good elements
40	Acceptable response in all areas
30	Acceptable response with some minor shortcomings, or poor response
	with some acceptable elements
20	Poor response in all areas
10	Very poor response that is significantly below expectations in all areas
0	No response, or inappropriate response in all areas

2 **Pricing proposals** - Evaluation made by comparison of pricing submissions - **20% weighting**.

This will be calculated as follows;

Lowest Price x Weighting + Tendered Price

Bids made over the budget would not be deemed as non-compliant.
